

401(k) Plan Administration Cycle

The 401(k) Profit Sharing Plan you established for your 2019 Tax Year is a qualified retirement plan approved by the IRS. Dedicated Defined Benefit Services (Dedicated DB) will work with you throughout the year to keep your plan in compliance with the IRS code and to support you in meeting your contribution and retirement savings goals. Your plan is administered on an annual cycle.
